# Nomination Guidelines

**Nominations will close September 27, 2024**

The workers of the aggregates, concrete and cement industries in Pennsylvania have helped to make our state what it is today! The PACA Hall of Fame has been established to recognize their often overlooked service to the industry and our communities that the worker quietly makes. While being nominated is an honor in itself, each year a number are selected to be added to the special rolls of the Hall of Fame. PACA is extremely proud to have inducted 125 outstanding individuals since the Hall of Fame's creation in 2000.

Nominees may be recognized by their companies or peers for significant contributions including, but not necessarily limited to, loyalty to a company through long term employment, leadership, safety, ingenuity, service to the community, service to their country, and/or stewardship to the environment.

To be nominated, the person must have good character, have shown enthusiasm for his or her work, have a good safety and work record, and have been an employee that has added value to his or her country, community company and/or the industry. Nominations are open to employees of producer and associate member companies and should be made by someone from the employee's company or a colleague with the approval of the employee's company to do so.

**Who Can be Nominated?**

Nominees may be a co-worker, superior, employee or a peer in the industry - as long as their employer is a member of PACA and the employer has granted permission for the nomination.

**What is the Nominating Process?**

Upon submittal of the nomination, the application is reviewed and the person submitting the nomination is contacted regarding status. **If the submittal is accepted, the person making the nomination will be asked to submit up to 5 photos of the nominee and to designate which of the five should be printed on the nominee's plaque by NO LATER THAN OCTOBER 25, 2024.**

**When and How is the Inductee Honored?**

Once the nomination is accepted and the nominee is now a Hall of Fame inductee, there are several methods of recognition for this honor. First, all inductees will be highlighted in an issue of PACA's biweekly e-newsletter, The Conveyor, prior to the Annual Meeting in November. Next, a publication including their photo and description of their accomplishments will be printed and distributed at the Annual Meeting in Hershey.

Their photo and plaque inscription will be printed on a poster or banner up that will be displayed during the Annual Meeting and at PACA's various events and in the PACA headquarters in Harrisburg for one year following the Annual Meeting.

The official induction ceremony takes place during the Honors Program at the Annual Meeting in Hershey. The person who submitted the nomination on the inductee's behalf will be contacted with details including date, time of arrival, etc. Inductees will be invited to the complimentary honors luncheon immediately following the program, along with one guest. If the inductee and/or his/her guest wishes to attend the entire Annual Meeting, regular registration rates apply.

During the induction ceremony, an emcee of the nominator's choice will highlight the inductee and present them with their plaque. A copy of the plaque will also be showcased in PACA's Harrisburg headquarters and a copy will be presented to the emcee for displaying at their company office.
